**OFFICE ORDER**

As per proviso to Rule 12 of Delhi Agricultural Produce Marketing (Election) Rules, 2000, the disqualification for being chosen as a member of a Marketing Committee is reproduced as under: -

- (a) If he has been convicted by a court in India of any offence and sentenced to imprisonment for a term exceeding six months unless such disqualification has been removed by an order of the Government.
- (b) If he has not attained the age of 21 years on the "qualifying date", or
- (c) If he is an undischarged insolvent: or
- (d) If he is of unsound mind and stands so declared by a competent court; or
- (e) If he is deaf-mute; or
- (f) If he has failed to pay any fees or charges due to marketing committee; or
- (g) If he is a Government servant or a servant of the Board or any marketing committee or local authority or public undertaking or holds a licence from such committee other than of a trader or commission agent or measurer and weighman; or
- (h) If he has committed breach of the Act or the rule or bye laws made thereunder more than once and has been convicted under this Act by a competent court; or
- (i) If he has failed to make payments to sellers.

It has been decided that while filing nomination paper, every candidate should furnish a certificate issued by respective Secretary of the Marketing Committee in the following format:-

“Certified that Sh. \_\_\_\_\_ S/o \_\_\_\_\_  
Partner/Prop. of M/s. \_\_\_\_\_  
is not defaulter in respect of market fee, payment to farmers or any other dues of  
APMC & DAMB as well as sellers”.

As regards choice to be exercised by the Candidates and allocations to be made by the Returning Officer, following instructions are issued: -

1. The candidates seeking elections will give their 3 options indicating preferences for the symbols allocated for the category shown above and not beyond that.
2. In case more than one candidate give their preference of the same symbol then the symbol will be allotted by the Returning Officer by draw of lots and the same course could be adopted second & third preferences for allotment by draw of lots.
3. If the preferences given by the candidates are exhausted for allotment, the Returning Officer will allot anyone of the symbols earmarked for the particular category.
4. In case the number of candidates is more than the symbols allocated for the particular category, anyone of the symbols of the reserved list or any other available symbols from anyone of other categories shall be allotted to the candidate seeking election.
