I am directed to inform that there is a proposal to fill up the following vacant posts of SE & Draftsman on deputation basis in this organization. As per Recruitment Rules, eligibility conditions for deputation are as under:-

(i) **Suptdg. Engineer (Civil) - 01** post in pay scale of Rs. 12000-375-16500 (pre-revised)

Eligibility- "Officer under the Govt./Govt. Undertakings holding analogous post or with 5 years service in the posts in the rank of Executive Engineer or equivalent and possessing degree in Civil Engineering from a recognized University".

(ii) **Draftsman Gr-I (Civil) - 01** post in pay scale of Rs. 5500-175-9000 (pre-revised).

Eligibility- (a) Holding analogous post on regular basis or (b) with 3 years service in the grade in the pay scale of Rs. 5000-8000 (pre-revised) or (c) with 8 years regular service in the grade in the pay scale of Rs. 4500-7000 (pre-revised) and possessing educational qualification i.e. Diploma in Draftsmanship from a recognized institution with at least 3 years practical experience in the line in an organization of repute after getting the Diploma.

Since, the Delhi Agricultural Marketing Board is a body corporate and Local authority as per Section 6 of the Delhi Agricultural Produce Marketing (Regulation) Act, 1998 and follows the Rules/Regulations/instructions of the Govt., the laid down terms and conditions of deputation of the Govt. shall be applicable to the officer on deputation basis.
