Sir,

I am directed to say that the following vacant posts are vacant and required to be filled on deputation basis in this organisation. The eligibility conditions for deputation of following posts are as under:-

(1) **Sanitation Officer- 01** post in pay scale of Rs.6500-10500 (pre-revised)

Eligibility- (i) Holding analogous post on regular basis, **or**

(ii) With 3 years regular service in the grade in pay scale of Rs. 5500-9000 (pre-revised), **or**

(iii) With 6 years regular service in the grade in the pay scale of Rs. 5000-8000 (pre-revised) and possessing the following educational qualification :-

(a) Graduate from recognized University.

(b) Diploma in Sanitary Inspector from a recognized Institution.

(c) 3 years experience in Sanitation line in Govt./Semi Govt. Organization.

(2) **Asstt. Secretary (Sanitation)-01** post in pay scale of Rs. 5500-175-9000 (pre-revised)

Eligibility- (i) holding analogous post on regular basis, **or**

(ii) With 3 years regular service in the grade in pay scale of Rs. 5000-8000 (pre-revised), **or**

(iii) With 6 years regular service in the grade in the pay scale of Rs.4500-7000 (pre-revised) and possessing diploma in sanitation from a recognized institution.

(3) **Chief Sanitary Inspector -01** post in pay scale of Rs. 4500-125-7000 (pre-revised)

Eligibility- (i) Officers holding analogous posts on regular basis **or**

(ii) post of Sanitary Inspector or equivalent post in the scale of Rs. 4000-6000 (pre-revised) having 5 years experience in Govt. Deptt./ NDMC, MCD, DDA etc.
